- LF 6. Public hearing on Ordinance (Bill No. 8-21) to allow for Multiple Primary Structures in the R-3 Zoning District.**
- Section 104.5 of Chapter XX of the Municipal Code (Zoning) currently restricts property in the R-1, R-2, and R-3 zoning districts to only one principal building per lot. The proposed amendment would remove the R-3 zoning district from Section 104.5 of Chapter XX. The Planning Board recommended the Ordinance amendment at its August 17, 2021 meeting.
- Ordinance (Bill No. 8-21) was introduced September 14, 2021.
- Recommended Action:* Conduct the public hearing.
- SS 7. Consideration of Ordinance (Bill No. 9-21) amending the Park Rules and open container ordinance to allow for an alcohol permit in certain pavilions.**
- Currently, alcohol is prohibited in all municipal parks. The proposed ordinance will allow alcohol in certain pavilions pursuant to a permitting system. The proposed ordinance also creates a corresponding exception in the Open Container Ordinance.
- Ordinance (Bill No. 9-21) was introduced September 14, 2021.

Recommended Action: Move to enact Ordinance (Bill No. 9-21) to amend the Municipal Park Rules and Open Container Ordinance to allow alcohol in certain pavilions pursuant to a permitting system.
