- AF 4. **Consideration of [Ordinance \(Bill No. 4-23\)](#) Amending the Charter regarding Commission Vacancies.**

Currently, the Mt. Lebanon Home Rule Charter provides that in the event of a Commission vacancy, the remaining Commissioners will appoint a qualified person to serve until the next available election. As recently demonstrated, this rule is cumbersome and sometimes confusing in that the next available election can require an extremely short-appointment term and a short-elected term. In addition, such election can take place when voters are not otherwise anticipating an election of this type at the municipal level. The proposed ordinance would result in Commission vacancies being filled on the normal two-year municipal election cycle found in the School Code, the judicial codes, and municipal codes for municipalities that are not home rule.

The proposed ordinance would place the issue on the November 7, 2023, general election ballot. The voters must approve the ordinance for it to be effective.

This ordinance was introduced May 23, 2023, and the public hearing was held June 13, 2023.

Recommended Action: Move to enact Ordinance (Bill No. 4-23).

ASW 5. **Consideration of Resolution No. R-9-23 for a sidewalk assessment program for municipal sidewalks.**

This Resolution is for the replacement of deteriorated sidewalks on the following streets: Cherokee Place, Hoodridge Drive, Nakoma Drive, Navahoe Drive, Ordale Boulevard, Pueblo Drive, Standish Boulevard, Terrace Drive, and Washington Road. This Resolution orders the replacement of deteriorated sidewalks by property owners or the municipality will cause the work to be done and invoice the owners.

Recommended Action: Move to adopt Resolution No. R-9-23.

CG 6. **Adoption of Resolution No. R-10-23 for Cochran Road and Larchmont Road Sewer Rehabilitation Project and Resolution No. R-11-23 for Little Saw Mill Run Sewer Rehabilitation Project for an Allegheny County Sanitary Authority (ALCOSAN) Green Revitalization of Our Waterways (GROW) Program Applications submission.**

Applications for an Allegheny County Sanitary Authority Green Revitalization of Our Waterways Program grant has been prepared for the following areas:

- Cochran Road and Larchmont Road (C4800-MB-L-03) - This sewer lining project includes the internal CIPP manhole to manhole lining of approximately 6,255 total linear feet of sanitary sewers, and manhole rehabilitation off of Cochran Road (R-10-23).
- Little Saw Mill Run (MH1800-MB-L-05) - This sewer lining project includes the internal CIPP manhole to manhole lining of approximately 8,900 total linear feet of sanitary sewers, and manhole rehabilitation off of Beverly Road (R-11-23).

The GROW grant program will reimburse the Municipality for eligible design and construction costs, as determined by ALCOSAN. If awarded, the Municipality can expect a minimum reimbursement amount of 15% of the total eligible design & construction costs.

The proposed repairs will contribute to the required corrective actions of the current Consent Order as they are located in areas above the established thresholds.

The grant requires a commitment from the Municipality and adoption of a standard resolution.

Recommended Action: Move to approve the submission of the Allegheny County Sanitary Authority Green Revitalization of Our Waterways Program Grant Applications and associated Resolution Nos. R-10-23 and R-11-23 of Municipal Commitment.

ORDINANCE NO. _____**

**AN ORDINANCE OF MT. LEBANON, PENNSYLVANIA,
AMENDING THE CHARTER REGARDING COMMISSION VACANCIES**

WHEREAS, the Charter provides that, in the event of a vacant seat on the Commission, due death, resignation, removal, or forfeiture of office, a majority of the remaining members of the Commission shall vote to appoint a qualified resident of the Municipality to fill the vacant seat, which appointee would serve until the next available election; and

WHEREAS, the Charter regarding the Municipal Treasurer's office, as well as most municipal codes in Pennsylvania, fill vacancies on the normal two-year municipal election cycle; and

WHEREAS, the Commission has found the different rule for the Commission to be cumbersome and sometimes confusing in that it can require an extremely short appointment term and elected term, and can take place when voters are not anticipating municipal elections; and

WHEREAS, the Mt. Lebanon Commission desires to change the Charter regarding the filling of vacancies; and

WHEREAS, the proposed amendment conforms with The Home Rule Charter and Optional Plans Law: 53 Pa. C.S.A. §§ 2901 et seq.; and

WHEREAS, the Commission seeks to submit a certified copy of this Ordinance filed with the Department of Elections of the County of Allegheny, Commonwealth of Pennsylvania to be placed on the November 7, 2023, election ballot.

NOW THEREFORE, Mt. Lebanon, Pennsylvania ordains that:

SECTION ONE:

Section 309 of the Charter is hereby amended to read as follows (deleted text in overstrike and new text underlined):

Section 309. Filling of Vacancies

If a vacancy shall occur in the office of the Commissioner for any reason set forth in this Charter, the remaining members of the Commission shall fill such vacancy by appointing a person qualified under this Charter from the ward in which the vacancy exists to hold such office ~~for the unexpired term thereof, or if the term thereof continues so long, until the installation of the person elected at~~ until 8:00 p.m. on the first Monday of January following the next available ~~primary, municipal or general~~ election occurring more than sixty (60) days after the vacancy occurs, ~~at which election an eligible person shall be elected for the balance of the unexpired term.~~ If the Commission shall refuse, fail or neglect, or be unable, for any reason whatsoever, to fill such vacancy within forty-five (45) days after the vacancy occurs, then the Court of Common Pleas of Allegheny County shall, upon petition of any Commissioner or of any five (5) citizens of the ward wherein the vacancy exists, fill the vacancy in such office by the appointment of a qualified resident of said ward ~~for the unexpired term of the office, or if the term thereof continues so long, until the installation of the person elected at~~ until 8:00 p.m. on the first Monday of January following the next available ~~primary, municipal or general~~ election occurring more than sixty (60) days after the vacancy occurs, ~~at which election an eligible person shall be elected for the balance of the unexpired term.~~ Notwithstanding the requirement in §315 that a quorum of the Commission consists of three (3) members, if at any time the membership of the Commission is reduced to less than three (3), the remaining member or members may by unanimous action appoint additional members to raise the membership to three (3).

SECTION TWO: The Department of Elections of the County of Allegheny, Commonwealth of Pennsylvania is hereby requested to place the above amendment on the Election Ballot for November 7, 2023.

SECTION THREE: In the event that the proposed change is approved by the electorate the amendment will take effect upon certification by the Department of Elections of the County of Allegheny.
