Advisory Board Transition: Lilley reported that Ian McMeans, the municipal planner, emailed the board a uniform set of policies and procedures that all the new boards will be required to follow. Some included items are members must inform the board liaison one week prior to the meeting if they will be attending. In-person attendance is encouraged over remote attendance, and remote attendees must have the camera turned on. Subcommittees will work on more specific tasks. One of the subcommittees of the Resiliency Board will be the Design Committee which will be involved in working on phase 2 of Vibrant Uptown called Active Uptown. The Mt. Lebanon Partnership received a matching grant for light installation art and will be working on ways to make Uptown a destination. The first meeting of the new boards will be an orientation.
