Bids were received on June 11, 2024 for the Mt. Lebanon Public Safety Center Roof Replacement Re-Bid contract. The project involves removal and replacement of existing EPDM roof system with new TPO roof membrane system, installation of insulation and replacement of roof coping and flashing at the Mt. Lebanon Public Safety Center. An additional alternate price for gutter repair work was also solicited.

The Municipal Engineer has verified the bids as follows:

Ramp Construction Co., Inc.	\$278,500.00	\$356,500.00

The Municipal Engineer has reviewed the bids and determined the low bid to be accurate. The Engineer recommends the project be awarded to Pennsylvania Roof Systems, Inc. The contractor has completed other similar and larger projects in the past in a satisfactory manner for Mt. Lebanon and other entities.

The budget for the project is \$305,780.00. The project is within budget and is to be funded through the Capital Fund.
