**Call to Order:** Anna Siefken called the meeting to order at 6:00 PM.

**Roll Call**

1. **Meeting Minutes:** Anna Siefken motioned to approve the August 2024 meeting minutes with one minor addition of discussion of sub-committees. Grace Raabe motioned to approve the minutes, seconded by Chet Wade. All members present voted to approve the meeting minutes.
2. **Citizen's Comments:** None.
3. **Commission Liaison Report:** Commissioner Siegler was traveling, no updates.
4. **Historic Preservation Committee Update:** Phillip Neusius informed the board that the historic preservation committee met and discussed the responsibilities of the resiliency board when it comes to historic preservation matters within the community, such as the status of the historic district.
5. **Sustainability + Local Ecology Committee:** Anna Siefken gave the update indicating that their subcommittee met on September 14, 2024. Each member of the subcommittee volunteered to research the Sustainability and Local Ecology topics. Chet Wade met with Commissioner Flynn and will meet with staff regarding the topics he has volunteered to study.
6. **Economic/Business District Committee –** Linda Topoleski informed the board that the economic/business district subcommittee met twice discussing the topics of the Activate Uptown Plan and the other business districts within the community.
