1. Meeting Minutes

The meeting minutes were tabled to the November 4 meeting.

2. Citizen Comments

Zuzana Ashwell, 308 Hazel Drive, voiced concerns regarding traffic speed on Washington Road especially during active school zone times.

Brent Wasko, 1483 Greenmount Avenue, Dormont, feels there is a safety issue in the 200 block of Dell Avenue with parking on both sides of the street.

3. Chairperson's Report

Mr. Davis said this is the Week without Driving and encouraged Mt. Lebanon residents to participate. He discussed concerns with drivers' habits in active school zones. He also discussed the Active Transportation Plan and how streets such as Dell Avenue may benefit from that plan.

4. Commission Liaison Report

Commissioner Flynn said the budget process has begun and invited the board members to attend budget workshops.

5. Staff Liaison Report

There was no staff liaison report.

6. Sub-Committee Reports

a. Capital budget

There was no report.

b. Policy

Mr. Ragan reported there should be a policy for the citizen street improvement to present to the board very soon. The sub-committee was encouraged to meet again to work on the core intent and questions raised while drafting the policy before presenting it to the board.

8. New Business

a. Street Reconstruction List

Mr. Davis tabled discussion because the list public works put together regarding a five-year project on the streets to be reconstructed is not yet available.

b. Street Design Sub-Committee

Ms Hurm moved, and Mr. O'Rourke seconded to create a street design sub-committee. The motion carried unanimously.

c. Scrubgrass Traffic Calming

Mr. Haberman of Gateway Engineers gave a presentation regarding short-term and long-term traffic calming measures.

Victoria Meister, 736 Scrubgrass Road, is concerned about car speeds on Scrubgrass Road.

Blaine Lucas, 744 Scrubgrass Road, voiced his concerns about speed and safety on Scrubgrass Road.

Maureen Kovalcik, 562 Oxford Boulevard, asked about an update for speed control on Kelso Road. Ms Hurm said Kelso Road is the first street on the board's recommendations for sidewalks.

Lindie Droulia, 300 Gilkeson Road, said she is concerned about pedestrian access to the new Timbercreek steps going to Inglewood Drive.

Ms Hurm moved, and Mr. Davis seconded to accept all recommendations including the bump out of the intersection area, and on-going collection of speed data for Scrubgrass Road. The motion carried unanimously.
