MINUTES OF THE ADJOURNED MEETING NOVEMBER 25, 2025 OF THE MT. LEBANON COMMISSION

The Commission of Mt. Lebanon, Pennsylvania, held an Adjourned Meeting at 8 P.M., on Tuesday, November 25, 2025. Commission President Craig Grella called the meeting to order and led the Pledge of Allegiance to the Flag. Manager McGill called the roll. Present were Craig Grella, Jeff Siegler, Anne Swager Wilson, Steve Silverman and Andrew Flynn. Also, present were Police Chief Haberman, Library Director Vittek, Finance Director McCreery and Assistant Manager/Municipal Planner McMeans. Phil Weis of the solicitor's office and Dan Deiseroth of the engineer's office were present.

COMMISSION/MANAGER'S ANNOUNCEMENTS

Manager McGill summarized the information that was reviewed during the discussion session, including a review of department and staff office goals for 2026. There were also updates on various activities from the commissioners for those boards to which they are liaison to.

CONSIDERATION OF THE MINUTES FROM THE REGULAR MEETING HELD NOVEMBER 11, 2025

INTRODUCTION OF ORDINANCE (BILL NO. 6-25) FIXING THE TAX RATE FOR THE YEAR 2026

The municipality will be fixing its tax rate in accordance with the adopted budget. The tax rate for general purposes is currently 4.50 mills. The tax shall be fixed at the rate of 4.50 mills for the year 2026 and continue in force for each successive calendar year without annual reenactment unless the tax is subsequently changed.

Mr. Flynn moved to conduct the public hearing.

Mr. Grella conducted the public hearing.

INTRODUCTION OF ORDINANCE (BILL NO. 7-25) ESTABLISHING COMPENSATION FOR EMPLOYEES FOR 2026

The ordinance establishes the pay rates and levels for employees, including those covered by collective bargaining for 2026. It also sets hours of work and overtime, longevity and fringe benefits.

Mr. Silverman introduced Ordinance (Bill No. 7-25) establishing compensation for employees for 2026.

CONSIDERATION OF RESOLUTION NO. R-17-25 AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION TO THE COMMONWEALTH FINANCING AUTHORITY'S STATEWIDE LOCAL SHARE ACCOUNT

The municipality, for the benefit of its citizens, wishes to submit a grant application to the Commonwealth Financing Authority's (CFA) Local Share Account (LSA), which provides support projects in the public interest within the Commonwealth of Pennsylvania.

The Municipality is requesting \$1,000,000 in funds for the Mt. Lebanon South Garage Demolition project, which is situated at 705 Florida Ave. This specific project aims to demolish the existing parking structure, although the overall project aims to reconstruct a new parking structure which could potentially include a mixed-use development atop of the structure.

There is no required municipal match required for this grant application.

Mr. Siegler moved, and Mr. Silvernman seconded to adopt Resolution No. R-17-25. The vote was called. The motion carried 5-0.

CONSIDERATION OF THE EXPENDITURE LIST FOR OCTOBER TOTALING \$4,527,530.44

Ms. Swager Wilson moved and Mr. Flynn seconded to approve the expenditure list for October totaling \$4,527,530.44. The vote was called. The motion carried 4-0 with Mr. Silverman abstaining due to his daughter's employment at Gateway Engineers. He provided a Memo and requested that it be filed with the minutes.
